

TERMS & CONDITIONS

DAILY MAVERICK DM168 “SLOW DOWN TO CATCH UP” COMPETITION (THE “COMPETITION”)

1. The promoter of this competition is The Daily Maverick (Pty) Ltd (“the Promoter” or “Daily Maverick”).
2. For purposes hereof, “Affiliate” means the Promoter’s partners, co-promoters and sponsors of this competition, Daily Maverick’s subsidiaries, and their subsidiaries and respective holding companies, the subsidiaries of their holding companies, and their directors, officers, employees, agents and representatives.
3. Entering the Competition constitutes binding acceptance of these Terms and Conditions, which will be interpreted by Daily Maverick, acting reasonably and lawfully.
4. Participation in the Competition and acceptance and/or use of a prize, or any aspect thereof, is at the Entrant’s own risk.
5. The Competition closes at 23:59 on 18 June 2021.
6. Daily Maverick may amend these Terms and Conditions at any time during the Competition, by posting such amendments on www.dailymaverick.co.za/promotion
7. Daily Maverick reserves the right to vary, postpone, suspend or cancel the Competition and any prizes, or any aspect thereof, without notice, at any time, for any reason which is deemed necessary. In the event of such variation, postponement, suspension or cancellation, all Entrants agree to waive any rights, interests and expectations that they may have in respect of this Competition and acknowledge that they have no recourse of any kind against the Promoters and Affiliates.
8. The Competition is open to all persons of 18 (eighteen) years or older and who live in South Africa (being a resident or citizen) except the employees of Daily Maverick and Competition Affiliates and their immediate family members.
9. To enter the Competition, Entrants will need to post three photographs of a purchased recent copy of DM168 (Daily Maverick’s weekly print newspaper) social media (Facebook, Twitter, or Instagram). In order to qualify, Entrants must have done the following:
 - a. Purchased three editions of DM168 (from Saturday 22 May to Saturday 12 June 2021);
 - b. Post a photograph of each edition on the social media platform of their choice;
 - c. Tag the relevant Daily Maverick social media accounts and use the hashtag (#DM168catchup);
 - d. The total number of likes for photographs across three editions will be added up;
 - e. A complete entry is composed of three photographs over four weeks (one of each respective edition); or one photograph featuring at least three editions of DM168 from 22 May 2021 to 12 June 2021).

 - a. A two-night stay at One&Only Cape Town

14. Winners will be contacted by email or social media after the draw. If there is no response from the winner within 3 days of the initial contact, that winner will forfeit the Prize and will have no claim against Daily Maverick or Competition Affiliates. In the event of a forfeiture as contemplated herein, Daily Maverick shall have the right to select a different entrant on the same conditions.
15. If so requested by Daily Maverick, the winner agrees to supply a valid identification document (SA ID or passport), proof of address and any other validation procedure determined by the Promoter or Competition Affiliates, in order to claim the prize.

22. These Terms and Conditions are severable and are governed by the laws of the Republic of South Africa.
23. Any provision of these Terms and Conditions which is held to be invalid or unenforceable shall be ineffective to the extent of such invalidity or unenforceability without invalidating or rendering unenforceable the remaining provisions.
24. By entering into the Competition, the Entrant agrees to the following indemnifications:
 - a. the Entrant indemnifies and holds the Promoter and its Competition Affiliates, their employees and agents ("the Indemnified Parties") of any and all liability pertaining to any damage, cost, injuries or losses of whatsoever nature and howsoever arising as a result of their participation in the Competition;
 - b. the Entrant accepts that the Indemnified Parties will not be responsible for any costs, damage or otherwise, howsoever incurred by a winner, subsequent to being awarded the prize or for a winner's inability for whatsoever reason to redeem or utilize a prize.
